Other Fees and Levies

Excursions/Trips	Any optional trips and tours offered by the College e.g. Music Tours, Language Immersions, Social Justice Immersions are billed separately. Day related curriculum excursions are covered by tuition fees.
Other Levies	May include but are not limited to: <ul style="list-style-type: none">– Cost of activities which do not form part of the school curriculum e.g. Year 12 Formal and Year 11 Semi-Formal, Valedictory Celebration.– Any items purchased by students where ownership is transferred from the school to the student e.g. Senior Jerseys. Please note: these charges will attract GST.
Co-Curricular Levies	Fees may be billed for participation in co-curricular activities including but not limited to non CaSSSA sport programs, dance troupe and debating. Private lessons are available in music.
Cancellation of Enrolment by Parent/Carer	Where a parent/carers of a student intends to cancel a student's enrolment, the College requires at least one Term's notice of the cancellation. Where the parent/carers fails to give at least one Term's notice, the College reserves the right to invoice the parent/carers an Early Enrolment Termination and Administrative Fee (\$1,000 + GST, in lieu of notice).

Voluntary Levies/Memberships

Building Fund	\$300 per year, per family. The College continues to operate a Voluntary Building Fund, with all donations being fully tax deductible.
Scholarship Fund	Provides financial support for the provision of scholarship and bursaries, with all donations being fully tax deductible.
Past Pupils' Membership	\$110 per student, Year 12 only.
